1.2.2019	1. APPLICANT asks for clarification about the nature of the signature required on each page of the document: should it be manual ink signature or electronical signature is acceptable. Can the Constracting Entity specify if the Participation Cover Letter and the JV Agreement can be signed electronically.	1. It could be manual or electronical signature, both are acceptable also for the cover letter and JV Agreement.
	2. Can the Contracting Entity specify what financial indicator is required in point 4.3 a) of the Tender documentation? Is candidate's creditworthiness? Can the Contracting Authority use the Czech terminology to name a given financial indicator?	2. Requirement in the point 4.3 a) relates to the company creditworthiness. NET4GAS recognizes five independent agencies which can be used by the suppliers – Dun & Bradstreet (failure score 50 or higher criterium), CreditReform (rating 250 or better), S&P and Fitch ratings (BBB- or better) or Moody's (Baa2 or better).
	3. "APPLICANT asks for clarification about the period of time the minimum turnover of EUR 200 million is applicable to: is it minimum EUR 200 million per year or minimum EUR 200 million for the total of the last three years? "	3. It is minimum EUR 200 million for the total of the last three years.
	4. "APPLICANT understands that it is expected to submit the "Žádost o prověření odborné způsobilosti a vydání oprávnění pro zahraniční subjekty ze států EU" forms fully filled: one for gas equipment and another one for electricity equipment. Please, confirm these two documents duly completed and signed are sufficient or the APPLICANT needs to obtain a specific authorization from Czech Republic authorities at this preliminary stage of the bidding process (Application). "	4. The Foreign Applicant shall prove technical qualification requirement according to point 4.4(b)(v) of the Tender Documentation by complete filled in and confirmed/signed <b>application</b> (www.ticr.eu). The authorization itself shall be submitted at the latest before the activity commenced (not at this stage of the tender).
	5. The Contracting Authority requires a license for the manufacture, installation, repair, inspection and testing of selected gas and electrical equipment issued by ITI in accordance with Act No.174 / 1968 (we consider that the Contracting Authority wrongly mentions the 1986 Act). Licenses and certificates of this capability do not include the word "manufacture", but the Authorization and Certificate of Assembly, Repair, Revision and Examination are included and this condition of the Contracting Authority should therefore be met in its entirety. Will the contracting authority consider the condition to be fulfilled in its entirety?	5. Yes, it is the Act No. 174/1968 Coll., as amended. The Contracting Entity require "Authorization and Certificate of Assembly, Repair, Revision and Examination". Yes, the title do not include the word "manufacture".
	6. The Contracting Entity is requiring to obtain all necessary permits from the potential contractor. Please, specify what permission you are referring to.	6. Please see Annex 1 of Contract Agreement - EMPLOYER'S REQUIREMENTS - file "General technical requirements" Chapter 2.15 - Permitting.
	7. It is Bidder opinion that itmes i) and ii) should be developed during the Tender phase upon preparation of a detiled execution plan and schedule of activites. Any information given before would not be supported by a proper analysis. Please confirm your acceptance.	7. These documents are required to be submitted as part of the Application, however documents will not be part of assessment of the qualification and will not influence the decision which Applicant will be called to submit it's preliminary tender bid.
