Reference is made to the Pipeline Welding Specification C4G-HPPL-ILF-GENER-LIN-SPC-801-801 paragraph 6.9 General requirements for the execution of the welding: Stop welding is possible after 2/3 of the weld size, Remaining 1/3 must be welded immediately following day. However also is stated that tie-in welds must be started and completed without interruption. Please clarify?	1. In the Specification a requirement is specified to execute the tie-in weld without interruption - in other words in one (1) day.
	2. Reference is made to the Pipeline Welding Specification C4G-HPPL-ILF-GENER-LIN-SPC-801-801 paragraph 6.9 General requirements for the execution of the welding: Minimum number of welders working simultaneously on one weld DN1400 is 4 welders. We assume this is only valid if GMAW, and when welding with semi-automatic or automatic process then 2 welders are allowed. Please clarify?	2. For the semiautomatic and automatic welding process the number of welders could be reduced. Precise number of required welders shall be specified in the Method Statement for the welding or Contractor Welding Procedure Specification. These documents are subject of Employer's approval.
	3. Reference is made to the SPRQ, tab Hourly rates. Rates for construction equipment have to be included with driver / operator. Please specify if this is also valid for items 18 onward e.g. Compressors, pumps, welding machines, etc.?	3. Yes. (It is assumed that the question is related to document C4G-HPPL-ILF-GENER-GEN-SEZ-848-000 Schedule of Hourly Rates for General Contractor, not SPRQ)
	4. According to the tender requirements the Contractor needs to perform pyrotechnical and archaeological survey in the ROW area. Since these surveys are performed on third parties land plots, the consent of the respective land owners is required. Please confirm that the Client already acquired the consent of all land owners that the Contractor can access their properties and perform the necessary surveys without necessity of additional permissions.	4. Client will acquire the consent of all land owners prior the Contractor construction need in order to access their properties and perform the necessary surveys.

In the documents "C4G-HPPL-ILF-GENER-GEN-TZP-019-000 Biological Survey - Report", "C4G-HPPL-AUT-ILF-0951-D-USP MZP-2P_EIA k záměru" and "C4G-HPPL-ILF-GENER-LIN-SPC-805-000" several different areas and construction restriction periods have been mentioned. Some of the restrictions are not reflected in the EIA or they are reflected with slightly different kilometers or periods. Additionally some of the restrictions areas are described as "around km...". Attached you can find a list of restriction areas what have been found in the different documents. a) We kindly ask you to confirm or correct our understanding of the restriction areas. b) We kindly ask a clarification, what does the Client understand under "around km...". How many meters before and after the respective point is the restriction area?	5.
