Written Report of the Contracting Entity

Recorded on May 29, 2019 for the tender "**INDUCTION BENDS FOR HIGH PRESSURE PIPELINE ("CAPACITY4GAS" PROJECT)**", which was published in the Public Procurement Bulletin on 21st of January 2019 under reg. No. Z2019-002153 in negotiation procedure with publication according to Section 3(d) of Act No. 134/2016 Coll., Public Procurement Act ("Public Procurement Act").

Subject matter of the public tender:

The scope of this tender was the supply of induction bends, subject to the terms and conditions set out in the technical specifications.

The scope of the tender also included the delivery of all documents required for the proper use and operation of the delivered goods.

Grounds for the contract award: The Contracting Entity received 1 Application in time in accordance with the Tender Documentation. Applicant Salzgitter Mannesmann Grobblech GmbH, with its registered office at Salzgitter Mannesmann Grobblech GmbH, Reg. No.: HBR 15471. Applicant fulfilled all qualification requirements and was called to submit preliminary tender offer.

The Contracting entity assessed the preliminary tender offer and called the Bidder to the negotiation, which took place at 24th of April 2019. The Bidder was asked after the negotiation phase to deliver the final offer, which the Bidder delivered in a deadline set by the Contracting entity.

The Bidder submitted a final Tender offer price in the amount of 5.317.203 EUR excl. VAT. The Contracting Entity has discovered a mistake made by Bidder in Annex 3 – Price list, where price items 1.6.1 and 1.6.2 has been counted twice, making the final bid by 88.192 EUR more expensive. The Contracting Entity asked Bidder, if his final Tender offer price is 5.229.011 EUR excl. VAT, which the Bidder confirmed. Due to the fact, that only one Tender Offer has remained in the public tender, The Evaluation Committee has not proceeded to evaluation of the Tender Offers pursuant to the Section 122 (2) of the Public Procurement Act. The Contract was then awarded to the only Bidder, who fulfilled all the legal requirements of the public tender and the Contracting Entity requirements set in the Tender Documentation, the Bidder No. 1 - Salzgitter Mannesmann Grobblech GmbH.

7. Grounds for the cancellation of certain Tender


The Contracting Entity has not canceled the tender.
